**SECTION 4 – FIRST AID MEASURES**

**4.1 Description of First Aid Measures**

Inhalation:	Not expected to be a problem under normal conditions of use. When finely divided, inhalation of dust may cause irritation of mucous membrane and respiratory tract. OSHA permissible exposure limit (PEL-TWA) and ACGIH threshold limit value (TLV-TWA) for respirable dust: 5 mg/m <sup>3</sup> . Total nuisance dust OSHA PEL-TWA: 15 mg/m <sup>3</sup> ; total dust ACGIH TLV-TA: 10 mg/m <sup>3</sup> . If heated to decomposition, fumes generated may result in respiratory irritation. ACGIH exposure limit for paraffin wax fume is a TLV-TWA of 2 mg/m <sup>3</sup> .
Skin and Eye Contact:	Not expected to be a problem under normal conditions of use. May produce mild irritation on prolonged contact with skin or eyes. Not expected to be absorbed through the skin in significant quantities. The cool solid material is not expected to cause skin or eye irritation; however, contact with molten material may result in thermal burns.
Ingestion:	May be harmful if swallowed. May cause gastrointestinal disturbances.
Emergency and First Aid Procedures:	Wash skin thoroughly with soap and water. Launder clothing before reuse. If in eyes, irrigate with flowing water immediately and continuously for fifteen minutes. Consult a physician. If inhaled, remove to fresh air and administer oxygen if necessary. If ingested, consult a physician. If molten polymer gets on skin, cool rapidly with cold water. Do not attempt to peel polymer from skin. Obtain medical attention for thermal burns.

**6.1 Methods and Material for Containment and Cleaning Up**
